_____ **Breeder.** All pet and show quality kittens will be spayed or neutered prior to leaving your cattery. **No unaltered breeding quality Cat/Kitten will be placed without written permission from Dr. Brian and Cynthia Bailey of Barebabies Sphynx Cattery.** This cat is not allowed to be used for Stud Service (if male) or to be bred (if female) to a stud cat from another cattery **without written permission from Dr. Brian and Cynthia Bailey of Barebabies Sphynx**

Barebabies Sphynx guarantees that the feline is free of Feline Leukemia Virus (FELV), Feline Infectious Peritonitis (FIP), and Feline Immune Deficiency Virus (FIV feline AIDS) at the time of purchase.

Barebabies Sphynx guarantees against hereditary or congenital defects that cause death to cat/kitten until five years of age. Cat/kitten will be replaced by a cat/kitten of equal value should cat/kitten die within that time (must be verified by a certified Veterinarian and accompanied by a complete autopsy and copy of full medical history). The seller is not obligated to replace the cat/kitten for any other reason other than those stated in this contract.

The buyer agrees to take the cat/kitten to a licensed Veterinarian within 48 hours to insure cat/kitten's health. If your Veterinarian finds any physical problems, which make it a health risk, you may return the cat/kitten to Barebabies Sphynx within 3 days of receipt for a full refund or exchange if possible. Buyer shall be responsible for any veterinarian and/or shipping costs that may incur.

Barebabies Sphynx will have completed all of the age appropriate vaccinations at the time of pickup. A copy of the vaccination record will be provided to the buyer.

Barebabies Sphynx will provide the buyer with a copy of the TICA registration papers. It is the responsibility of the buyer to submit the TICA paperwork to TICA or any other organization. Barebabies Sphynx guarantees that the feline is able to be registered with TICA and with other Cat Associations.

Barebabies Sphynx show quality kittens are guaranteed to show and be within The International Cat Association Standards. Barebabies Sphynx does not guarantee how well the cat or kitten will show and or place.

Barebabies Sphynx breeder-quality cats and kittens are guaranteed to reproduce, and be of the best quality to the breed standards. If for some reason the female does not become pregnant within a 2.5 year period, she will be returned to Barebabies Sphynx at owner's expense. Barebabies Sphynx will use a stud to ensure the female is able to breed. If she does become pregnant, Barebabies Sphynx will keep one of the kittens, and the female will be returned to the owner at the owner's expense. If the female does not become pregnant, and is determined by Barebabies Sphynx not to be able to breed, then

Barebabies Sphynx will provide another cat or kitten to the owner in exchange for the non-reproductive female.

Barebabies Sphynx is not responsible for any expenses incurred during the process. If the owner would prefer a refund, the female would be returned to Barebabies Sphynx at the owner's expense. The owner will be entitled to a refund only if a licensed Veterinarian determines the female to be infertile. Once documentation of this procedure is provided, a refund will be issued for the purchased price. Barebabies Sphynx will be given 120 days to provide the refund to the buyer. The refund **does not include** the deposit.

The buyer shall keep the cat indoors in a clean, pleasant environment, and generally un-caged. The cat shall not be allowed outdoors, except in a proper carrier or enclosed run that provides adequate protection from the elements, other animals, and disease. The buyer shall provide the cat/kitten with the proper nutrition, health care, and companionship. Barebabies Sphynx retains the option to inspect the cat and its living environment upon giving reasonable notice to the buyer.

The buyer accepts the responsibility of caring for this cat/kitten and providing properly for its welfare.

The buyer agrees to follow the Barebabies Sphynx instructions on care, housing, diet, treatment and health.

The buyer agrees that this kitten will always receive prompt, top-notch medical care, and will never be allowed to harbor parasites.

The buyer agrees to provide companionship for this cat/kitten, never leaving it alone for long periods of time without human attention. The buyer agrees to provide a generous amount of exercise for this cat/kitten, to provide it with a scratching post and not to cage it.

The buyer agrees **never to declaw** this cat/kitten, and understands that declawing is a mutilation and a cruelty that is likely to alter the kitten's temperament, affect its health, and endanger its life. A simple scratching post nearly always resolves the problem.

The buyer agrees that, if any of the above terms are disregarded, Barebabies Sphynx may reclaim this cat/kitten **without a refund** of the purchase price. The buyer agrees to pay all court costs if this contract is litigated, and agrees that the case will be litigated in Boyd County Kentucky.

The buyer will maintain reasonable contact with Barebabies Sphynx for the first two years of this cat/kitten's life by providing updates on the cat/kitten's health, behavior and overall temperament. Barebabies Sphynx will not be responsible for any routine veterinary costs.

The Buyer must notify Barebabies Sphynx of change of address, telephone number or email address.

Under no circumstances shall the cat/kitten be sold, leased, or given away to any person, breeder, pet store, laboratory, research facility or animal shelter. If the buyer is unable or unwilling to properly care for the cat/kitten, it shall be returned to Barebabies Sphynx **without refund at the buyer's expense.**

Barebabies Sphynx shall not be held liable for any veterinary or health care costs occurring while the cat is in the possession of the buyer.
